He had been to work some hours and worked out a pretty good sized hole in the bottom of the corn, and pretty soon he went to punch some more down when the great mass caved in, coming with such violence against the fork that it pushed the handle through his hands and on into his stomach, tearing a fearful wound, and felling him to the floor, where the corn rolled down in torrents upon his almost lifeless form, bruising and scarring him up in a most painful and frightful manner. He was too badly injured to give the alarm, and remained in a semi-unconscious condition for some time, when he was found and taken to the house, when medical air was summoned and all done that was possible to ease his pain and save his life. At the time our informant left there he was still alive, but fears were entertained of his recovery. Mr. Brock is one of the oldest and best known farmers of this section, and has been a resident of Andrew county for years.

The report on Sunday morning last, July 13th, that Major Joseph Brock, of Hackberry, had committed suicide, startled our community. It was known for several weeks that the Major's mind was impaired and that he was failing fast, and on account of his mental condition a watch was kept over him, not knowing what he might attempt to do.

About two o'clock Saturday night last, after the family had retired, the Major was heard to get up and leave the room in which he was sleeping. His granddaughter, who heard him go out the door, ran to look after him and saw him going towards the well. She immediately gave the alarm, and the young men who were sleeping in the house arose and rushed out, when they heard the well buckets in motion, and just as they arrived at the well a bucket filled with water came to the top with such force that the water splashed out into the yard. A lantern was brought and it was discovered that the Major was in the well. There was a bucket at each end of the chain, and when the Major jumped in the well he descended with the empty bucket, which caused the other one to ascend.

The neighborhood was at once alarmed and when a few of the closest neighbors arrived a young man descended into the well and found the Major wedged in at the bottom with his head down, proving conclusively that he jumped in head foremost. A rope was placed around him and he was drawn out, life being extinct. An examination showed that his head was bruised up considerably. The well is about 45 feet deep, with about three feet of water.

Major Brock was 81 years of age and one of our most respected citizens. He has been living in Andrew county over forty years. He leaves an aged wife and four married children. He was a member of the Ben. Franklin Masonic lodge and was buried at the old Baptist church on

Hackberry by that fraternity on Monday afternoon last, his funeral being attended by a large concourse of friends and neighbors.

Judge Brooks was a Virginian, having been born in the 'Old Dominion' in 1819, being sixty-six years and seven

months of age at the time of his death. While very young he removed with his parents to Rockcastle county, Kentucky, where he lived until he came to Andrew county, in the spring of 1857, when he located on the land which he made his home until a few years before his death, when he took up his residence on First street, of 'Christian Ridge,' in this city. He has served the people of Andrew county faithfully as County Court Justice, both by election and appointment, and this service was the means by which his excellent qualities of head and heart became generally known to the people throughout the county. He was an indulgent father, a kind husband, a good citizen, and a faithful friend. He became a member of the Christian Church while residing in Kentucky, and continued a consistent member until his death. Eight children survive him-- six girls and two boys, as follows: Elizabeth Burnsides, of Andrew county; Mary, wife of A. J. Bostwick, of Craig, Holt county; Elvira, wife of Ellis Davis, of DeKalb county; Susan, wife of B. K. Holt, of Miles City, Montana. Deceased at the time of his death, was sixty-six years and seven months of age.

One of the well-marked characteristics of Judge Brooks was his generosity and kindness. This he showed in many ways and on all occasions. Twice appointed and once elected by the people, he served upon the bend of our county court with universal satisfaction to all. He seemed to 'drink in' as it were, the very wants of the people and his quick perception of the right and abhorrence

for the wrong, gave to all his acts a significance that was impressive. In his personal intercourse, too, he was always kind and affable. Of a jovial and pleasant disposition, he was extremely fond of making everyone feel free and easy, with whom he came in contact. He was respected by his neighbors, loved by his children, and for his manly frankness admired by his friends. His sympathies always went out toward the disconsolate and unfortunate. A member of the Christian church, he bore up under pains that were most excruciating, with christian fortitude and resignation.

Judge Brooks died at his residence, in Savannah at 3 o'clock a.m., on Saturday, Oct. 17. The funeral took place at the Christian church on Sunday afternoon, and notwithstanding the inclement weather, the church was filled to its upmost capacity and many cheeks were bathed in tears and sobbing hearts, giving evidence of the great esteem they had for him. All that was mortal and genial of our friend and fellow citizen is hushed in an eternal sleep. No words of ours could, if we would, recall him from the blissful shores of eternity. This simple tribute to his memory is all that we can give, and we would feel that we had been recreate to the best feelings of our heart, if we had not paused long enough to lay our simple wreath on the tomb which covers the mortality of this good man.

Brooks, circuit clerk of this county; Mrs. Elizabeth Burnsides, Mrs. Wayne McBeath, and Mrs. Abbie Brooks, of this county; Mrs. A. J. Bostwick, of Holt county; Mrs. Ellis Davis of DeKalb county, and Mrs. B. K. Holt, of Montana. All of his children save Mrs. Holt, were at his bedside when he died.

Judge Brooks was very popular and highly esteemed. He was three times a judge of the county court of this county, twice by appointment and once by election. In his family relations he was a devoted husband and a fond father. His funeral took place from the Christian church in Savannah, of which he was a consistent member, on Sunday afternoon last and notwithstanding the disagreeable weather it was largely attended showing the appreciation in which he was held

by those who knew him. The services were conducted by Elder J. W. Damon who preached an excellent sermon.

J. C. Brooks shot himself in the city park sometime after 1 p.m. He took a shot-gun from his home that he had borrowed from Wm. Clasbey, about two weeks ago, to kill something that had been disturbing his chickens, and walked by the cemetery to the park by the west entrance and around the pavilion and shot himself about a block northeast of that, while reclining on an incline on the west side of the road. He discharged the gun with his cane, taking the top of his head and eyes off, leaving the lower part of his face distorted and unrecognizable. His hat and a large piece of skull were found about six feet away. The train men on the noon Maple Leaf freight saw the body and took the section men, who were down the track. They told Agent Byergo, who notified Prosecuting Attorney Pyle, who found the following unfolded note pinned to his vest and his coat buttoned over it:

'I have concluded that I am no account, crippled and without friends, so have concluded to finish myself. I want Fred Terhune to take my body to his undertaking room for burial in the Savannah cemetery in my lot. I don't want to be taken home. No inquest is needed as I did it myself and have contemplated it for some time. I want to be buried as soon as possible and as cheaply as possible. This gun belongs to William Clasbey. Get my friends as pallbearers.

'J. C. Brooks.'

He had written the note in the morning in the saloon. He was a member of the Co-Operative Burial Association.

Col. Brooks had been a trustee for the Bellis heirs for about ten years for \$800 and was short about \$300, and Monday was the day set for settling with the new guardian, E. D. Bonham, of Platte township.

At one time Mr. Brooks was worth several thousand dollars. He was kind-hearted, had many friends once, but years of dissipation reduced all.

Joseph Carson Brooks was born in Rockcastle county, Ky., Sept. 28, 1848, and died May 21, 1906, aged 57 years, 7 months and 23 days. He came to this county with his parents in 1857. He

lived with his parents near Kodiak till a grown man, was married to Marian McKnight, daughter of James McKnight, Jan. 3, 1875, Miss Leona Brooks being the only child of this union. He began school teaching in early manhood and taught about eight years. While threshing he received a serious injury which resulted in the loss of his leg Sept. 5, 1882. During the same fall he was elected Circuit Clerk and held that office eight years. Previous and subsequent to this he has held various offices of trust. When a young man he became a member of the Christian church and was for some years the Superintendent of the Sunday-school of the Christian church in this city.

On last Monday afternoon our people were much startled by the news that Col. J. C. Brooks' dead body had been found at Glendale park, just south of this city. He had gone to the park about one o'clock, carrying with him a shot gun which he had rented of the W. H. Clasbey Hardware Co., and had shot himself through the head.

As the Maple Leaf local freight, which leaves this station at 1:40 was passing the park the crew noticed the body of a man with a shot gun by it in the park and when the train came up with the section men they were told of the find. These immediately brought the word to town and H. B. Pyle, prosecuting attorney, and R. H. Gamble, sheriff, went to the park.

When coming to where the body was the manner of his death was plainly seen. He had gone to the hill just a little northeast of the pavilion in the park and had placed the muzzle of the gun between his eyes and had discharged it with his cane. The load tearing away the greater part of his face and head.

J. F. Terhune was ordered to bring the body to his undertaking establishment, where it was viewed by Coroner C. O. Jefferies, who deemed it unnecessary to hold an inquest.

The following statement was found pinned to his vest:

'I have concluded that I am no account, crippled and without friends, so have concluded to finish myself. I want Fred Terhune to take my body to his undertaking room for burial in Savannah cemetery in my lot. I don't want to be taken home. No inquest needed as I did it myself and have contemplated it for some time. I want to be buried as cheap as possible and as soon as possible. This gun belongs to Mr. Clasbey. Get my friends for pall bearers.'

About two weeks ago Mr. Brooks went to the Clasbey hardware store and rented a short gun saying that dogs were annoying his chickens and that he wanted to shoot them. A few days later he returned the gun and when asked if he got the dogs he replied that he had not, but would try it again if the dogs did not let his chickens alone. About two weeks ago he again went to Clasbey's and got the gun with which he took his life, again saying he was going to shoot dogs.

A little after noon he was seen going to the park with the gun and those who saw him thought strange of it, because he had never been seen with a gun before.

His body was prepared for burial at the Terhune undertaking establishment, and funeral services were conducted from the Christian church by Rev. A. R. Hunt Tuesday afternoon and burial was at Savannah cemetery.

Joseph Carson Brooks was a native of Kentucky and was born in Rock Castle county, that state, on September 28, 1848. He came to Andrew county in 1857 with his parents and has been a continuous resident here since. His parents located in the Cherry Grove neighborhood where he attended school and grew to manhood. He was married to Marion [sic] McKnight, daughter of James McKnight, January 8, 1875, Miss Leona Brooks being the only child of their union.

In his early life be became a school teacher in which calling he spent some eight years, and as a young man there was none whose future was brighter or more full of promise.

On September 5, 1882, he was assisting in threshing at his fathers [sic] home when he met the accident that crippled him for the remainder of his life. The machinery was run by horse power and the men who were operating it were out of oil and the boxing on the cylinder became so hot that the machine caught fire. Mr. Brooks got upon the box and had poured a jug of water upon the fire and was reaching for another when he lost his footing and one leg went into the cylinder and it was taken off just above the knee.

On September 30, 1882, he was nominated by the democrats for circuit clerk and was twice elected to that office by good majorities, notwithstanding the fact that the county was strongly republican and that he had a majority of 400 to 500 to overcome. He filled this office with credit and honor to himself, his friends and the people throughout the county. Previous to and since that time he has held other public offices.

When a young man he became a member of the Christian church, and was for some time superintendent of the Sunday school. He leaves, aside from his wife and daughter, one brother and five sisters, his parents, three brothers and two sisters preceding [sic] him to the better land.

Leona Brooks was born six miles east of Savannah, Mo., January 5, 1879, and passed away in the Sister's [sic] Hospital, St. Joseph, Mo., Sunday afternoon, September 2, 1923 at 4 p.m⁴.

Her father was a native of Kentucky, having come here in 1857, the mother was a native of Wisconsin coming to Andrew County in 1886 [sic⁵]. [The two families lived joining farms.]⁶

Miss Leona grew to girlhood in Andrew County, and graduated from the Savannah High School. She afterwards attended Fayette college but for only one year because of ill health. Later she took a commercial course in the Platte Commercial College of St. Joseph and became a stenographer in the office of Booher and Williams in Savannah and remained in that position for several years. She made herself very efficient in the affairs of this office, having as great an interest in the business there as thought it was [sic] her own. On account of the very heavy war work, the stress in the office was great, three or four years ago she was taken with the flu and never fully recovered from its effects.

Miss Brooks from early childhood assumed her share of the responsibilities of the home, and played the part of a good helper to both her father and mother in the affairs of life. She was a constant companion to her father in his business life going with him over the country and doing everything possible to make his burdens lighter. So was her life felt in the home in these younger years. She has been true and faithful to her good mother in her declining years as any daughter could be. To her there was no place like home, everything about the home showed her touch of interest. A splendid neighbor, none better. She had a quiet forceful way about her by which she made friends and kept them. Patient and sympathetic towards all people, and especially interested in those who had experienced sorrow. She will be sadly missed by the good mother and other of her relatives and friends.

Funeral services were held in the home Tuesday at 1:23 [sic] p.m. conducted by Rev. Seelig, pastor of the Presbyterian church and interment was in the Savannah Cemetery.

Brooks, who for the past ten or twelve years had been Northwest Missouri's most popular auctioneer, died at his home in this city last Friday morning, aged 51 years 1 month and 26 days. Col. Brooks had been a sufferer for some time from indigestion and two weeks before his death this took on an acute form and resulted in his death.

Col. Brooks was a native of Andrew county, being born five miles east of Savannah, and a son of the late James Brooks, one of the pioneer settlers of the county. He continued to live on the old homestead up to and for one year after his marriage to Miss Mary H. Peters, daughter of Judge and Mrs. Peters, of Cosby, on March 1, 1882. He purchased Judge Peters' farm near Rochester some years after his marriage and continued to reside there until he moved to Savannah about ten years ago. He still owned the Peters farm at the time of his death.

Col. Brooks and wife were blessed with two children, Earl, and Mrs. Pearl Seckles, who with their mother survive him. Aside from his family he leaves five sisters, Mrs. Susie Holt, of Montana; Mrs. Elizabeth Burnsides of Kodiak; Mrs. Ellis Davis and Mrs. John Patterson, of Union Star, and Mrs. C. W. McBeath, of Rochester. All of these sisters, save Mrs. Holt, were present at his burial.

The taking off of Col. Brooks, deprives Andrew county of one of the most useful men ever known in her history. As an auctioneer he was emminently [sic] successful and he was so well posted in values that hardly ever did he sell anything for less than its worth. Farmers having sales on hand would wait weeks for him and last season he had sales booked ahead for nearly three months. During his ten years [sic] residence in Savannah he has cried not less than 1500 farm sales aside from many little sales of household goods, etc., held in the towns. He began his career

as an auctioneer nearly twenty years ago and his first sale was at the Lillibridge farm near Rochester. Since living in Savannah he had devoted most all of his time to his profession and no client was ever disappointed by him. It has been estimated that Col. Brooks has cried 2500 sales during his life.

He was a member of the Elk lodge of Odd Fellows at Helena and the Knights of Pythias at Rochester. Both of these orders were in attendance at his funeral which took place at the Christian church last Sunday afternoon, with one of the largest assemblages ever gathered on such an occasion, in this city, and which alone sufficiently testifies the high regard in which he was held.

The services at the church were conducted by Rev. A. R. Hunt and at the cemetery the service of the Odd Fellows was used.

Besides her parents, the child is survived by two brothers and two sisters, Virgil, Irvin, Inez and Opal. Two of the children, Inez and Virgil, attended the picnic.-- Democrat-Forum, March 26.

James B. Brower was born in Clermont county, Ohio, September 15, 1825; went at eight years of age to Jennings county, Indiana, where he grew to manhood. He was united in marriage to Miss. E. B. Bailiff in 1846. Later they removed to Marion county, Iowa, and in 1853 to Harrison county, Missouri, where they reared to maturity a family of ten children, three of whom with their mother preceded him in death.

He was at one time a dealer in merchandise, about 1857 and 1858. He was in [sic] an early day assessor of Harrison county. In the early 'seventies' he was one of the judges of the county court, and was a member of the legislature in the 28th and 29th general assemblies.

In 1891 he removed to Kingman county, Kansas, where he lived until May, 1909; since which time he has made his home with his son, Rev. M. F. Brower, at Hamburg, Iowa, where he died Saturday, January 29, 1910; aged 84 years, 4 months, 14 days.

He served as a Union soldier and first lieutenant and later captain of Co. A, 35th Mo. Vol. Inf.

Judge Brower was a man of strong character, industrious and persevering, of a religious nature and took a great interest and an active part in public affairs; charitable and considerate of the views and opinions of others, yet never concealing his, or shirking a duty. He was never afraid to admit a mistake if he made one. And like the rest of mankind he did not altogether escape them.

In his family he was kind and indulgent. His substance was theirs. He was a good provider and he divided generously. To the church he gave liberally of his time, services and means. At the time of the Johnstown calamity he called on the writer, handed him a sum of money, and said, 'I haven't time to write; you send this in for me.'

The other children in the family are all well known in this county where the greater part of their lives so far have [sic]been passed.

In 1879 Mr. Brown sold his farm in Ohio and moved to Ellis county, Kas., where he resided until 1881, when he moved to Missouri and settled in Nodaway county in the neighborhood where he died.

He was recognized as a worthy man, one who made friends. It is said of him that he was noted for those acts of kindness that made him considered a good neighbor, even ready to run on an errand of mercy.

In early manhood he united with the Baptist church. In addition to the wife and children he is survived by one brother, Maranda, who was present at the funeral, and one sister, who lives in San Francisco, Cal.
