Mary Ellen Davidson, of whose demise The Journal last week made mention, was the daughter of Frank M. and Hattie A. Clark, and was born in Ottawa, Ill., on May 11, 1855. In 1870 she came with her parents to Clarinda where for a couple of years she attended school and afterwards taught some of the rural schools of the county, among them Tarkio and McCowen. On March 12, 1874, she was united in marriage to Hi Davidson who was at that time owner and manager of a livery stable in Clarinda. Soon after their marriage they moved to Bolckow, Mo., where they resided for a few years. From they removed to the farm of John Liggett about five miles northeast of Clarinda, thence to the Orme farm north of Hawleyville, and then bought and moved to a farm three miles west of New Market. After a few years residence there the health of Mrs. Davidson began failing and they moved to Hawleyville where they lived one summer with their son-in-law and daughter, Mr. and Mrs. P. W. Owen, thence back to the farm, which they sold shortly afterward and purchased a splendid home on the outskirts of New Market, and there on Sept. 12 [sic], 1908 at 8:30 p. m., Mrs. Davidson "Fell into that dreamless sleep that kisses down her eyelids still." Her funeral discourse was prefaced by a poem entitled: "He giveth His loved ones sleep." The last verse is here added by request of friends:

Oscar Holland, who lives near Krug Park, brought to the city today details of the horrible death of the five-year-old son of John Clark, a well-known Buchanan County farmer who lives five miles northwest of the city.

Farmer Clark was engaged Tuesday afternoon in clearing corn stalks and other rubbish off of one of his fields, preparatory to planting a crop. Several straggling shocks of fodder dotted the land. The farmer decided to burn these, and gave his older children permission to set them afire. In the meantime, the five-year-old child had left the house nearby and playfully hidden himself in one of the shocks of fodder. Nobody knew his whereabouts and it is presumed that the little one fell asleep.

The match was applied to the shock that sheltered the child and it was soon a mass of flames. The work of firing the other fodder in distant parts of the field took the members of the family away from the place where the child slept as soon as the blaze was started and if he screamed, nobody heard him.

It was over two hours after the harrowing error, that the facts were known. In the meantime, the boy's absence from the house had been noted, and the whole family turned out to search for him. Presuming that the child might have gone to a neighbor's house a short distance away, the father started to make inquiry, going across the field. Thus it was by a mere accident that he found the charred remains of his boy as he passed by a spot where the fodder had so recently been burned.

At a glance he saw that the child had been literally roasted alive. The frenzied parent wildly clasped in his arms the crisp corpse, and as he ran to the house to tell the awful news to the other members of the family, the cooked flesh of the little body dropped in shreds. The parents are almost crazed with grief.

John Clark is one of the best known farmers in this county, where he has been a life-long resident. Until recently he lived near Easton.

Norris and Duke say that the accident happened so quickly that they cannot account for it, neither can anyone else, except that it was Whitney's time to go and he went.

A woman and two men going from Tarkio to St. Joseph were the first at the accident and the next were attorney G. C. Sparks, wife and son and Mrs. Oren Clark and Ernest Brand, also returning from the game. The young man from the Tarkio car assisted Mr. Sparks to get Whitney into Mr. Sparks' car and they took him immediately to the Ensworth hospital, where he passed away at 12:40.

Highland Clark, one of the oldest and best known citizens of Andrew county died at Maryville February 24, 1916 and was buried at Savannah last Sunday afternoon. His death was sudden and unexpected and resulted from a paralytic stroke on Thursday morning about 8 o'clock. Without regaining consciousness he peacefully passed away two hours later.

The funeral service, conducted by Rev. A. W. McGlothlan from the home of his brother George W. Clark was largely attended by relatives and friends of the deceased.

Highland Clark was born on the old Clark homestead one mile northwest of Savannah, September 25, 1842. His father was Jeremiah Clark of Rockingham, N. H. Mr. Clark as a boy worked on his father's farm and attended the district school as he had opportunity. He was the third oldest child in a family of twelve children the following of whom are still living: James H. Clark of Savannah, George W. Clark of Savannah, A. T. and James S. Clark of Maryville, Mrs. Ed. Harman of Nardin, Okla., and Mrs. Addie Carter of Savannah.

As a young man, Mr. Clark enlisted in Kimball's regiment Company A. Missouri volunteers, October 17, 1861. He was married to Miss Rosella Barnes December 3, 1865. Four children were born to this union all of whom survive as follows: Mrs. Olga Lindsey of Denver, Colo., Mrs. Della Laney of Pueblo, Colo., Mrs. Myrta Tansill of Brownville, Texas, and Blaine Clark of New York City. After his marriage, Mr. Clark, for about three years, engaged in the contracting business. He then went into the grocery business which he followed for thirty-seven years. At the end of this time, he sold out his business and went to Texas to visit his younger daughter, Mrs. Tansill. While here, his wife died April 20, 1914.

His father, Jesse Clark, moved to Missouri and settled in Clay county, a few miles north of Liberty, when the subject of this sketch was but a lad. In 1840 he came to Andrew county in company with his brother-in-law, Henry Eppler, and entered land near what was known as old Jim Town. He returned to Clay county in the fall of 1840, and in 1841 was married to Mary Prather whom he survived by 21 years and 8 months. Of this union nine children were born, six of whom are still living, and save one-- S. M. Clark, of Howell county, Mo.,-- were present at his funeral. He remained in Clay county until the year 1849, when he moved to Andrew and located near Flag Springs, where he spent his time among his children, but mainly with Hugh R. Clark, at Savannah. In early life he espoused the cause of Christ and united with the Cumberland Presbyterian church to which he was much devoted, and in which for many years he acted in the capacity of Elder. He donated the site for the first church building erected in the northeast part of the county, and hauled most of the material for its construction from St. Joseph that being the nearest point at that time at which such material could be procured. For the support of his church he often contributed beyond his ability, and for the well-being and happiness of his family individually and collectively there was no personal sacrifice he would not cheerfully make. He possessed many of the faults and weaknesses common to men. His life was by no means without its mistakes, but they were traceable to errors in judgment rather than to intention. He was credulous and confiding toward those in whom he had confidence and this quality often made him the victim of that large and growing class of lofty pretenders, that infest every community. In politics he was formerly an old Whig but when the war broke out he became a Republican of the most pronounced type. He entered the army in April, 1862 and served until the same date in 1865, being a member of Captain H. B. Johnson's Independent company of light artillery. He has

been rapidly failing, physically, for more than a year and about Feb. 8, was compelled to take to his bed. After the first day he made no complaint of suffering any pain, but said to those in attendance that he would never recover; as to his future he expressed perfect satisfaction to those with whom he conversed on the subject. Funeral services were conducted at the M. E. Church by Rev. H. Norman, of St. Joseph, who also preached his wife's funeral sermon at Flag Springs, twenty-one years ago. And now, father, farewell. The frail and tottering form is hid from view. Thy council, which was ever on the side of mercy and peace, will be missed; but the recollection of thine acts of devotion will be blotted from memory's page only when the chilling touch of death's icy hand shall forever still the hearts that loved thee.

The body of the lineman was removed to Sidenfaden's morgue where an inquest will probably be conducted by Coroner C. F. Byrd this afternoon. Clark lived on St. Joseph avenue, and is said to have been married.

Albert Gallatin Clarke, Montana pioneer and one of the best known and leading merchants of Helena and eastern Montana, crossed the great divide yesterday. His death was a painless one-about five o'clock in the afternoon he dropped into a quiet slumber, and an hour later, without ever waking, he had passed away.

A. G. Clarke was not only one of the Montana pioneers, but he was also one of the state's pioneer merchants, and of Helena as well. The news of his death will be received with deep regret by hundreds of old timers in all sections of the state, and more particularly by many in this city who have good reason to remember Mr. Clarke's kindness of heart at other Christmas seasons.

While his death was not unexpected by the immediate members of his family, nevertheless it came most suddenly. For three months Mr. Clarke had been gradually failing, but it was within the last six weeks that he has entirely given up the details of his affairs to other hands. He did not have any decided sickness-- just a gradual failing and wearing away. He suffered no pain whatever, and the end was in reality a quiet and peaceful death.

Mr. Clarke was born in Terre Haute, Ind., April 7, 1822. He was of Scotch descent, his ancestors locating in Connecticut. When he was 19 years of age Mr. Clarke went to Andrew county, Missouri, where he worked on a farm for about a year. Then he went to Savannah, in the same state, where he engaged in the mercantile business. Later he went to St. Joseph, where he also engaged in mercantile pursuits. In 1862 he went to Denver, where he remained for two years, and at the end of that time returned to St. Joseph. But the western fever had taken a strong hold upon him, and two years later he crossed the plains [illegible] ...ive point being Virginia City, in this state. He stayed there about a year and then came [illegible] here he formed a partnership with Thomas Conrad and engaged in the mercantile business, the first location being on State street, just below Rodney. Later the firm became Clarke, Conrad and Curtin, and until a year or two again was one of the best known in Helena. Several years age Mr. Clarke, in conformity with a desire to get out of active business, disposed of his interest in the old house. He was also a member of the firm of Raleigh & Clarke, dry goods dealers. In addition, he was interested in mercantile enterprises in different parts of the state.

In the early years he engaged in cattle growing and was among the first to import fine stock into Montana. He had a partiality for Durhams, and in 1864 brought a good bunch to Montana. He continued in the cattle business until about 10 years ago.

No man in Montana had a more active life than Mr. Clarke. In addition to his mercantile and stock growing interests, he was a heavy investor in realty in Helena and elsewhere in the state. While not an active mining speculator, he aided in the development of a number of mining properties, and several of his investments in that line proved profitable. But he was not a mining man. He was one of the incorporators of the Montana National bank of this city, and was for a number of years a director of the bank, and at one time vice president.

He was a Mason of long standing, having been a master in a lodge in Savannah, Mo., more than 50 years ago. He was a Knight Templar, and until recently took an active interest in Masonic affairs, having organized a number of lodges in different parts of the state. In politics he was an uncompromising democrat, but he was not a politician nor an office seeker, though he was a liberal contributor to campaign funds in the days when he took a more active interest in the election results. The only public office he ever held was that of county commissioner, and he resigned that before his term expired.

Mr. Clarke was one of the early members of the Methodist Episcopal church, South, his connection with that church dating back 50 years. For many years he was one of the trustees of the Helena church of that denomination, and at many crucial times in the history of the church was its mainstay.

Mr. Clarke leaves four children, Madora, the wife of W. G. Raleigh, Charles A., Albert G. and William R. All reside in Helena save the last named, and were with him when he died. William was notified yesterday of his father's death, and until some word is received from him, the date of the funeral will not be set.

One of Mr. Clarke's oldest friends died about a year ago. That was Edwin Toole. For more than 60 years the two had been the warmest friends. For many years they lived within a stone's throw of each other, and each day they met. Just before Mr. Toole's death, Mr. Clarke was unwell and could not leave his home. Neither could Mr. Toole. Still the friends communicated with ach other each day, exchanging letters.

The family here have [sic] no particulars of how George came to the fatal accident, but it is supposed he was taking his usual evening horseback ride and the horse became unruly and threw him. It had been George's practice to take his exercise by riding a horse each evening after he had finished his work at the bank. He was a thorough horseman.

L. J. Clayton, a brother of the deceased, arrived in this city from Ashland, Neb., Sunday night in response to a message announcing the death. Mrs. M.J. Quinlan, a sister, who lives at Gilman City, and R. A. Clayton, a brother, who lives at Creston, Iowa, will arrive Monday evening.

The accident which resulted in the death of George Clayton occurred Saturday night about 11:30 just as a party of young people were nearing the ranch house on the Clark ranch 25 miles from Caspar, where they were to be the guests Sunday and Monday. The party consisted of four young ladies and four young men. They left Caspar about 8 o'clock for the Clark ranch and as they neared their destination they missed the road leading to the ranch. George, who had been out there frequently, headed the party in search of the right road and as he found it put his horse to a gallop and called the others to follow.

A wire gate that had always been left open had been closed that night and the horse ran against it and threw George over his head, fracturing the skull.

He was taken to the ranch house, about a mile distance, and a physician summoned from Caspar, but George died before the physician arrived without having recovered consciousness.

The body was taken to Caspar Sunday and prepared for burial, a short funeral service being held Monday morning before the train arrived.

George made a host of friends at Caspar, as is evidenced by the fact that the boys accompanying the body to Maryville were given \$50 by the people of Caspar to purchase flowers to be used at the funeral here.

Of Andrew county's 586 soldiers who were in the service, ten died from disease and four were killed in action, and now the first one discharged rom the service to die is R. Jerry Clemens of

northwest of Rosendale. He was slightly ailing when he came home with tonsilitis, which grew worse steadily.⁶

Reynold J. Clemmens [sic] was born in Andrew county April 29, 1896, and departed this life September 6, 1919, at the age of 24 years, 4 months and 8 days. He was baptized November 11, 1917, and united with the Centenary M. E. Church.

At the beginning of the war he was one of the first of the community to be called by the selective draft and left for Camp Funston September 19, 1917, remaining at the training camp until April 6, 1918, when he sailed for France, serving with the Third Division until the close of the war, when he was sent with the Army of Occupation to Germany, and remained there until the army was recalled to the United States, leaving August 8 and reaching New York August 22, when he was sent to Camp Taylor, Kentucky, where he received an honorable discharge, arriving home August 29, 1919, wearing the six stars indicating service in the Champaigne-Marne defensive, Aisne-Marne offensive, St. Mihiel offensive, Meuse-Argonne offensive at Rheims and in the Army of Occupation. In the memorial address it was said⁷:

'No doubt it was under the protection of God in answer to his father and mother's prayers that he was enabled to go through so many battles and finally arrive at home, only to go to his Maker one week after his arrival. He was dearly loved by his relatives, friends and companions. He came home with as pure a character as he had when he left, never yielding to the temptation to smoke cigaretts [sic⁸], nor to drink nor to gamble.'

He leaves to mourn his going, father, mother, three brothers and two sisters, A. B. Clemmens of Craig, Mrs. Lucy Gillie, Mrs. Anna Drydale of near Bolckow. Ross Clemmens of Rosendale, six nephews and three nieces and many relatives and friends.

Funeral services were conducted at the Gravelwall [sic] Church September 8 at 2 p.m. with the address by Rev. R. Poe of Graham, and the body was laid to rest in the Savannah cemetery. Six soldier boys of the Third Division acted as pall bearers.

Savannah, Mo., March 20.-- A startling discovery was made this morning by a Mr. Landers, living a few miles west of this place. He was engaged in repairing fence, when he came upon the dead body of a man suspended to the limb of a tree in Kit Gee's pasture. He at once made the matter known and telegraphed for the coroner, who resides at Rosendale. The unfortunate was identified as a man who had been working on a farm for Mr. Gee for the past year, and was regarded as a crank. He was hanging, at the time Mr. Landers found him, with his feet touching the ground and one of his hands resting on the fence. He had carried his design into effect by tying a silk handkerchief around his neck and fastening it to a shirt attached to a limb. He had been missing about three weeks, and from the appearance of the corpse, when found, had been dead during that time. The stock had torn off a portion of his clothing, and the birds had disfigured his face and head by picking out one eye and picking at his ears and face. The coroner has not yet held the inquest.

For about a year Lewis Clemmens, a Pennsylvania German farm hand, has been working on the C. H. Gee farm, two miles and a half north of Savannah. He did not talk much, but seemed just tolerable sensible in conversation, sometimes a little flighty. The only time he is remembered to have referred to suicide was one, when one of the young ladies remarked that robbers and murderers were sure to be caught and punished, he said that he never would be captured—he would hang himself first. Three weeks ago, last Monday morning, he arose before any one in the house, built a fire in the kitchen, but left just before the household came down, taking with him his clothes, a garment which he intended to use for an overcoat, and a pone of bread and a pie. The family never saw him afterward, and supposed he had run off.

Last Tuesday morning, about 10 o'clock, while Mr. Isaiah Landers was hauling rails on an adjoining farm to build fence, had unloaded and was about to start for another load, he happened to observe the figure of a man suspended from the limb of a tree in the woods pasture of Mr. C. H. Gee, in a spot but little frequented. The alarm was given, word was send to town and a messenger to Rosendale for Coroner R. P. Beall, and soon a huge number of curious people had assembled. The suicide was hanging from the limb of a tree, near the southeast corner of Mr. Gee's farm, the limb being about six and a half feet from the ground, his head leaning forward and a little to one side. He had evidently with great care prepared a platform by placing one end of a rail between the rail of a fence and the other end between a cluster of trees, then fastening a shirt securely to the limb, and making a noose of a silk handkerchief, fastened it to the shirt above, placed it about his neck, and then slid off quietly into eternity. When found his feet were on the ground, but his steady weight upon the limb for weeks no doubt bent it to that extent. Every indication was that he had been hanging there for some time. His eyes were picked out, his hands mutilated and also ears, probably by birds. Upon his person was found a one cent piece and about thirty keys of all sizes and kinds. In a cave in Landers' field, about a hundred yards

from the timber where he hung, was found the article he probably intended to use as an overcoat, which he took from the house when he left. On his person was a letter from Pine Ridge, Schulkill county, Pennsylvania, signed by Solomon Warrior, but contained nothing but commonplace intelligence. It is said the deceased talked both French and German very fluently.

Coroner Beall and Dr. A. Mullinix arrived from Rosendale about noon, and a jury was empanneled [sic] as follows: Allen Holt, E. L. Todd, William Holiday, Ed. Carter, P. Lahr, Monroe Wyatt. Witnesses were examined, the body viewed, and the verdict rendered that the deceased came to his death by strangulation at his own hands.

The body was taken down and removed to Rosendale for burial.

On Tuesday last news reached town that a man was found suspended from a limb of a tree in the pasture of C. H. Gee, situated about three miles north of Savannah. In a few minutes all kinds of reports were in circulation, and it was asserted by some that the dead man was a horse thief, and that the Vigilantes had strung him up and left him hanging as an example.

The Democrat at once dispatched a reporter to the scene of action to gather the particulars, when the hanging was found to be a veritable case of suicide, and the elevated gentleman no other than Louis Clemmens, a hired hand of C. H. Gee. Clemmens was a native of Schuylkill county, Pennsylvania, and had been living with C. H. Gee for the past year. He was a man of about 25 or 30 years of age, a good scholar, being able to speak three languages, but with all rather cranky at times.

It appears that on the morning of the 26 of February last, Clemmens started from the house of C. H. Gee, bareheaded for the purpose of going to the barn to feed the horses. He did not return, and Mr. Gee couldn't imagine what had become of him, but naturally came to the conclusion that he had, in one of his cranky spells, left the country. He so believed until Tuesday last when Isaiah Landers who was repairing the division fence that runs by Gee's pasture discovered Clemmens hanging from one of a cluster of trees in the southwest corner of Gee's pasture. The place is satiated about 1/2 mile from Gee's house, and is rather a secluded place. Clemmens repaired to this place, placed a rail from the fork of the tree to the fence, then tied an extra cotton shirt, which he had with him, by the sleeves to a limb of a tree, and then to that he tied a silk handkerchief, the loop of which, secured by a good knot, was placed around his neck, and then he jumped from the rail upon which he was standing, no doubt bidding a long farewell to this vain world.

The condition that Clemmens was in when found showed that he had been hanging there for some time. He had turned black and the flesh had been eaten off of one hand, and the birds had picked out one eye and had also been feasting on his ears and lips. The cause of Clemmens' suicide is a mystery. He has been in correspondence with a lady in Michigan for some time and has always destroyed her letters after reading them. He left nothing to show what caused him to commit the rash act.

Coroner Beall summoned a jury, which after the examination of the witnesses brought in a verdict that the deceased came to his death by strangulation committed by his own hands. The coroner took the body to Rosendale where he had it buried.

Josiah Clymen was born in Franklin County, Pa., May 3, 1827, and died March 22, 1905, at the age of 77 years, 10 months and 17 days. He removed to Iowa in 1854 and was united in marriage to Nancy M. Hendrickson March 4, 1857. In 1875 he united with and has since remained loyal to the Dunkard church. In 1880 the family came to Nodaway County, Mo., where they have made their home until the present day. Eleven children were born of this union, ten of whom [with] his wife, survive him.
